5. No extra divisions should be opened without prior approval of the government.
6. No change in medium, place, serial number in which the school is granted, in any condition it should not be changed.
7. To which Executive committee permission is granted to run the school and at which place permission is granted no change should be made.
8. The educational institution has to follow the rules and government orders issued under Karnataka education act 1983(Karnataka act 1-1995) without fail.
9. This primary school registration is permanently un aided as per government notification number ED:175 PMC-95 dated:7-9-1998 and dated:29-12-1998.
10. The Executive committee should submit affidavit on stamp paper sworn before notary to the effect that they don't desire any found from the government.
11. The text books and examination programs should be followed as per the instructions of department and government.
12. Violation of medium and mother tongue as per language rule to class 1 to 5 as per government order number ED:28 PGC:94 Dated:29-4-1994 is noticed the registration will be cancelled.
13. The schools violating language rule abide by the order passed by the court and government.
14. To start the school the Executive committee should credit deposit amount jointly in the name of block education officer and joint secretary of executive committee.
15. Ratio of teachers and staff should be as per rules in each class, registration of 50 students and attendance of 40 students should be maintained.
16. Schools registered under Karnataka education act sub rule 8 and sub rule 36- 39 are coming under purview of recognition and provisional recognition.
17. Medical examination should be done to all students as per rules.
18. School working hours and days should be followed as per rules.
19. The information of students registration should be reported to block education officer within 2 months of opening the school, if school is not

opened and conditions violated the present order will automatically cancelled.

20. The separate toilets to boys and girls should be provided, drinking water facility should be done.

21. The school should be kept safe from the fire, wind and electric short circuit and all precautionary majors should be taken as per national building code of India 2005.

22. Fire extinguishers should be installed in the school, all the teachers and staff should be trained to operate.

23. All facilities should be provided to teaching and non-teaching staff as per Karnataka education institutions rules 2005.

24. The service security to all teachers should be given as per government order number ED:104 SEP:2005 dated:12-1-2006 and amendments on time to time. Service registers of teacher should be maintained minimum salary of Rs.12500/- should be paid.

25. The qualified teachers should be appointed as per government order number ED:104 SEP:2005 dated:12-1-2006.


26. For the class 1 to 5 teachers having qualification PUC, TCH/D.Ed and for classes 6,7,8 the qualification having graduation(BA. B Ed/ B.Sc B Ed) should be compulsorily appointed as per commissioner's public instruction Bangalore circular number C7(2) PRASHIA:HOSHAPRA:ANU:1:2011-12 dated:3-5-2012 of child education right act.

27. The school should be started if and only if the teachers studied in Kannada medium are appointed.

28. The school registration is for 2013-14 hence 1st STD in Kannada medium should be started, in 2014-15 2nd STD, in 2015-16 3rd STD, in 2016-17 4th STD and in 2017-18 5th STD should be started on natural growth system.

29. As per Karnataka education act the books, library, playground and sittings should be provided within one year, otherwise the registration will be cancelled.

30. If the proposed school building is rented, the certificate should be obtained from the block education officer about school building and basic facilities are satisfactory.

32. The accounts of educational institution should be got audited by the chartered accountant for every year.
33. The rules should be followed in admission of students and recovery of fees strictly.
34. School and school premises, admission of children's in the schools should be kept open to all.
35. The school building should be made available for training, examinations, Janagnati of department activities.
36. All facilities should be provided as per Karnataka education institutions(classification, restriction and lesson system) rules 1995.
37. After completing all restrictions within two months the application for 1st recognition should be submitted to block education office.
38. The permission is given with the condition that the classes from 1 to 5 should be in Kannada medium and started after getting approval from the concerned authority .
39. If any documents submitted along with registration proposals find false the registration will be cancelled.
